1. I acknowledge the risk inherent in the activity of hunting. I voluntarily assume the risk of danger of injury or death inherent in the activity of hunting.

2. I RELEASE, DISCHARGE AND PROMISE NOT TO SUE Owner and/or any of Owner's members, managers, employees, lessees, agents or authorized representatives for any loss, liability, damage or cost whatsoever arising from their negligence or alleged negligence. I SPECIFICALLY AND KNOWINGLY AGREE THAT I EXPRESSLY INTEND TO RELEASE the entities and persons described herein from THEIR OWN NEGLIGENCE.

3. I HEREBY RELEASE, DISCHARGE, INDEMNIFY AND HOLD HARMLESS Owner and Owner's members, managers, employees, lessees, agents and authorized representatives from and against any loss, liability, damage or cost arising from, related to, but not limited to, my activity on the Premises and claims by third persons and/or entities which relate to or result from my activity on the Premises or any activity arising from or relating thereto.

4. I agree to fully compensate Owner and Owner's lessees for any loss or damage which they sustain arising from or relating to my activity on the Premises or any activity arising from or relating thereto.

5. I agree that this Permission and Release Agreement is governed by the laws of the State of Arizona and is intended to be as broad and inclusive as is permitted by Arizona law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.

6. I acknowledge that this Permission and Release Agreement is a revocable license. I understand that the permission granted is gratuitous and revocable at the Owner's will. Under no circumstances shall Owner be liable in damages of any nature or kind for revocation of permission.

7. I agree to comply with all statutes, rules and regulations applicable to my activity on the Premises.

8. I agree to comply with the Owner's Rules to which I have agreed in writing, which are incorporated herein, and that my failure to so comply automatically terminates the permission granted herein.

9. The terms hereof shall survive expiration, termination and/or revocation hereof.
